## NETCHEMISTRY IS AWARDED THE ELECTRONIC ENROLLMENT AND ELIGIBILITY CONTRACT FOR SAN DIEGO'S COUNTY MEDICAL SERVICES (CMS), PROGRAM

NEWPORT BEACH, Calif., September 27, 2007 - NetChemistry, a top-tier provider of mission-critical, highly secure software to the Health Services Sector, today announced that they have been contracted by San Diego's Health and Human Services Agency (HHSA) to implement AuthMed, a web-based paperless enrollment and eligibility determination platform.

The County Medical Services (CMS) Program provides necessary medical services for San Diego County residents aged 21 through 64 years, who have no financial resources for medical care and meet prescribed income limits and other eligibility criteria. Eligible individuals can receive primary care, hospital emergency and inpatient care, and medically necessary approved medical services and medications. In fiscal Year 2006-07, the CMS Program provided care to approximately 17,600 certified eligible individuals for a program cost of approximately \$67 Million.

"Electronic enrollment and eligibility determination are the cornerstones to improving access to healthcare," said Chris Cruttenden, President of NetChemistry.

CMS processes approximately 40,000 paper applications per year. In order to streamline the eligibility process, HHSA's CMS Program has contracted NetChemistry to implement AuthMed their Electronic Eligibility System. The AuthMed System will eliminate some of the current paper processes and increase timeliness in determining eligibility for patients. In addition, the system will automatically send eligibility notices to patients, and electronically transfer eligibility data to HHSA's Fiscal Intermediary, AmeriChoice. The new system will allow for electronic storage of all patient demographic data, and enhanced reporting mechanisms needed by the CMS Program. Care providers will have 24/7 online access into an applicant's eligibility through AuthMed's Provider Online Verification (POV) website.
